










Privacy Policy for S3FOOD Map

| <p>What can the S3FOOD site do?</p> | <p>S3FOOD publishes a map referencing the companies involved in the food industry. The map mentions personal information on a contact person within the referenced company. The use of this personal information is strictly supervised.</p> | |
|  <p>Who processes the data on S3FOOD?</p> | <p>S3FOOD processes the data jointly with its partners who check the consistency of the data of the companies concerned and the contact details of the natural person mentioned as the contact point by the company (the “Directory contact”).</p> <p style="text-align: center;">To learn more about S3FOOD, please consult its legal notice.</p> | |
|  <p>Why is data collected ?</p> | <p>Collection Purposes</p> | <p>Lawfulness of processing</p> |
| | <p>The coordinates of the Directory contact within the referenced company are processed in order to integrate them on the map and database published on the S3FOOD site and to update them annually (if necessary). These coordinates allow the actors of the sector to have information on the contact point of a company referenced on the map.</p> <p>These contact details are made public only if the Directory contact has accepted it.</p> | <p>Data subject consent.</p> |
| | <p>The coordinates of the Directory contact can be used by S3FOOD partners in order to put in relation the companies referenced on the site and the map.</p> | |
| | <p>The contact details of the company's CEO are collected so that S3FOOD can identify who is the legal representative of the company concerned.</p> | <p>Legitimate interest of S3FOOD to know who the CEO of the company is.</p> |
| | <p>S3FOOD uses the e-mail address of the CEO and the Directory contact to transmit information on the different opportunities and / or news related to the food supply chain concerned by the S3FOOD project.</p> | <p>Legitimate interest of S3FOOD to transmit information to the actors of the concerned sector.</p> |
| <p>The data are not sold, rented or exploited commercially by S3FOOD or its partners.</p> | | |
|  <p>What data does S3FOOD collect ?</p> | <p>First name Last name Profession Email address Phone number</p> | |
|  <p>Where does the data come from ?</p> | <p>The data is collected directly from you or through the Directory contact of the company concerned (in the event that the CEO's data are transmitted by the Directory contact).</p> | |
|  <p>Who uses the data ?</p> | <p>The data is accessible to S3FOOD partners, to S3FOOD support service and transmitted to providers who help S3FOOD to provide the service (data host for example). With your agreement, the contact details of the Directory contact are made public.</p> | |

|  <p>How long is the data kept?</p> | <p>As long as the map is online (April 30, 2022), unless the individual's consent to appear on the map is withdrawn. In this case, the person's data will be deleted immediately.</p> |
|  <p>Where is the data kept?</p> | <p>The data is stored on servers located in France. The data is not transferred to countries outside the European Union.</p> |
|  <p>What are your rights to the data?</p> | <p>You can access your data and request to update (complete or correct) your data.</p> <p>S3FOOD uses your data because you have given your consent. You can withdraw this consent at any time.</p> <p>You can be opposed to receive communications by e-mail (newsletter) on behalf of S3FOOD by clicking on the link of un-subscription appearing at the bottom of e-mail.</p> <p>You can ask S3FOOD to delete your data.</p> <p>You can ask for the use of your data to be suspended.</p> <p>S3FOOD treats your coordinates, "of Directory contact " within the referenced company, on the basis of your consent. You can request that your data be transmitted on a readable medium to another person who wishes to use your data.</p> <p>You can arrange what happens to your data in the event of your death (under French law).</p> <p>You have the right to lodge a complaint with the supervisory authority concerned (CNIL).</p> |
